1. Apologies:

2. Notification of late items for inclusion on the agenda

It was agreed that items 14.10 and 14.11 should be included as late agenda items.

3. Standing Order 61: To decide whether the public and press should be excluded from the meeting for any item.

It was agreed that the public and press should be excluded from items 11.4, 11.5 & 14.10.

4. Reports from Maidstone Police / PCSO and KCC Rural Community Warden

The clerk reported crime figures provided by PC Steve Older as follows:

- Two incidents of burglary (money stolen from Village Institute, disco equipment stolen from builder's yard in Heath Road)
- Nine incidents of theft (two motor vehicles; dumper truck and other items, tools, sensor from security light, tumble dryer, garden ornament, digger, horse buckets).

KCC Community Warden, Liz Lovatt reported that fly tipping had increased over the Christmas holiday period (mainly car wheels and tyres). She stated that doorstep sellers with no peddler's licences had been knocking at doors in Meadow View Road and that utility companies had been door knocking in The Quarries. An air rifle had been fired at ponies in Green Lane and Liz stressed that incidents like this should always be reported to the Police. She also reported that two men had been seen poaching in the Loose Valley.

Cllr Fuller mentioned that the recent Borough Council's 'Fit for the road – Maidstone safety review' had requested that Parish Councils notify Kent Fire and Rescue of any new areas where young people are gathering in cars. The purpose of this was to give Kent Fire and Rescue the opportunity to visit young people at these spots and educate them with regard to road safety.

5. **Open Quarter:**

Cllr Fitzgerald stated that he had received calls from several members of the public regarding concerns relating to the Albion public house. Cllr Fitzgerald stated that he could organise a meeting with the Borough Council's licensing department if necessary. It was agreed that such a meeting should be arranged.

- 10.1 It was agreed that Cllr Fitzgerald should chase up the Borough Council regarding payment of the £7000 grant for the village hall upgrade works. **CLLR FITZGERALD**
- 10.2 The clerk stated that the £15,000 grant for the village hall upgrade works had now been received from KCC. As such, it was agreed that the £15,000 transferred from the Parish Council's National Savings and Investment account to cover bill payments associated with this work should now be transferred back to the National Savings account.

11. Correspondence:

- 11.1 MBC Parish Precepts 2010/2011: Cllr Fuller proposed that the precept for 2010/11 be kept the same as for 09/10. Cllr Ellis proposed that the precept for 2010/11 be increased by 2% from 2009/10 to a value of £35,400. Cllr Ellis stated that this 2% increase would equate to a change for a band D property from £27.97 to £28.52. Cllr Munford seconded Cllr Ellis's proposal. 8 for, 3 against therefore it was agreed by a majority to increase the precept to £35,400 for 2010/11. Clerk and Chairman signed MBC precept form. Clerk to forward to MBC.
- 11.3 KCC grant for broadband services to rural parishes: Clerk to pursue application with KCC. Cllr Witherington agreed to co-ordinate technical side of the application.

Cllr Munford stated that he had spoken to KCC Rights of Way Officer, John Pelham and that any future repairs to footpath KM109 were the responsibility of KCC and not the Parish Council.

In addition, it was agreed that two new salt bins should be purchased, one for the top of Bottlescrew Hill / junction with Cliff Hill Road and one for the top of Wierton Hill.
- 14.6 Kent Highways Parish Seminar 24th November report by Cllr Fuller : Cllr Fuller stated that he had attended this seminar and that a presentation had been given on

county wide traffic speeds. Cllr Fuller stated that it had also been noted at the seminar that Kent Highways have been paying districts in some cases to clear highway verges rather than carrying out the work itself. Cllr Fuller wondered whether Kent Highways would consider paying the Parish Council to clear verges in Brishing Lane. He advised that the relevant KHS contact was Alan Riley. Clerk to pursue.
