1.    **Apologies:** Apologies were received from Cllrs Bray, Gershon, Ellis, Slater, Brown, Date and Clarke. Apologies were also received from County Councillor, Gary Cooke
2.    **Notification of late items for inclusion on the agenda**  
None
3.    **Standing Order 61: To decide whether the public and press should be excluded from the meeting for any item.**  
No excluded items.

At this point (7.05pm) the Parish Council meeting was suspended to allow a planning meeting to take place, which had originally been convened for immediately after the Parish Council meeting. This was brought forward as residents in attendance wished to speak about planning application 14/505113 Beresford Farm, The Quarries. The Parish Council meeting reconvened at 7.30pm.

4.    **Reports from Maidstone Police / PCSO and KCC Rural Community Warden**  
It was noted that no Police report had been received in advance of the meeting, despite the clerk chasing this.

KCC Warden, Liz Lovatt spoke as follows :

- A decision has now been made by KCC to retain all uniformed wardens. There will be a reduction in the number of supervisors and admin staff however
- A series of thefts has occurred from cashpoints and pay points in the Maidstone area. A poster warning about this is on display in the Church Street noticeboard
- A project is just getting off the ground to provide a garden in Maidstone for special needs children. Some funding for this has already been obtained

5. **Open Quarter:**

Nothing was brought up under this item.

6. **Declarations of Interest in Items on the Agenda / Declaration of Changes to the Register of Interests / Requests for Dispensations :**

All members declared an interest in item 9 as trustees of Boughton Monchelsea Amenity Trust. Cllr Skinner declared an interest in item 15 relating to Furfield Quarry.

It was agreed to bring forward item 11.2 on the agenda to allow parishioner, Mrs Black, to speak.

- 11.2 Mrs Black – War memorial : It was noted that a letter had been received from Mrs Black regarding the war memorial plaque that has been erected by the Parish Council recently in the foyer of the village hall. Mrs Black claimed that a number of names were missing from the memorial and should be added. Cllr Munford stated that the Parish Council would be happy to amend the memorial if undisputable evidence could be provided that the fallen men were residents of Boughton Monchelsea when they died, served in the armed forces and were killed in conflict. He added that the memorial at the primary school would have included additional names as pupils who had attended the school would not necessarily have been living in the parish when they died.

Cllr Munford suggested that Cllr Brown should continue to work with Mrs Black in an effort to carry out the necessary research and provide the concrete details required.

Cllr Munford thanked both Mrs Black and Cllr Brown for all their efforts on this to date.

Cllr Munford noted that the village hall had been chosen as a suitable location for the plaque as the original hall had been a memorial in itself. It was agreed that a sign should be put up at the entrance to the village hall with a suitable name and contact number for visitors to call to gain access to view the plaque. **CLERK**

7. **Matters outstanding from minutes (4<sup>th</sup> November) not included in agenda:**

Item 7 / 13.3 : The clerk agreed to arrange purchase of a secure cabinet for the parish office, for storage of radios and other items. **CLERK**

Item 7 / 9 Furfield Park : Cllr Munford advised that the Parish Council had been in contact with Taylor Wimpey's Managing Director for the South East, who although sympathetic to the issues residents were facing with OM, could not assist.

Item 13.4 Neighbourhood Watch : Clerk to contact Patricia O'Toole regarding date for next Neighbourhood Watch meeting. **CLERK**

Item 14.3 Carols on the green : Cllr Munford thanked all members and the clerk for their help in putting on this event.

Item 15.1: Cllr Munford noted that the Maidstone wide traffic survey was still in progress

Item 16.1 : Cllr Munford stated that he would be attending the farewell church service on Sunday 18<sup>th</sup> January and would present Rev Davis with the retirement gift from the Parish Council.

**8. Minutes of the meeting held on 4<sup>th</sup> November 2014:**

The minutes of the Parish Council meeting held on 4<sup>th</sup> November 2014 were agreed as correct. The minutes of the extraordinary Parish Council meeting held on 14<sup>th</sup> October were also agreed as correct.

**9. Clerk's report**

The contents of the clerk's report were noted. The following points were highlighted:

- Number 59 bus service : The clerk noted that she had attended a meeting on behalf of the Parish Council, with representatives from KCC, Arriva, Maidstone based secondary schools and other Parish Councils. Helen Grant, MP had also attended. A further meeting was planned before April.
- Bus service : The possibility of providing a minibus service to get children to and from school was discussed.
- Albion pub : Cllr Munford noted that a number of residents had queried what was happening to the Albion pub. The clerk advised that the property was apparently withdrawn from sale some time back and that the owner is carrying out the work, apparently with a view to selling it when complete
- KCC member funding : It was noted that a request had been made to KCC member, Cllr Eric Hotson, for funding for HGV signage at Cliff Hill and highway safety mirrors at the Green Lane / Church Street junction
- Furfield Quarry : It was noted that following a meeting between BMAT trustees and Taylor Wimpey, a site meeting would be taking place in February to establish the scope of works to be carried out by Taylor Wimpey before BMAT would consider taking over maintenance of the area. Cllr Ellis advised that he would be attending this meeting.
- Parkwood Farm reservoir : It was noted that the Parish Council's insurer, Zurich, had confirmed that the PC had adequate insurance cover in place for the reservoir
- Village sign on the green : The clerk advised that the sign was about to be re-erected on the green, complete with a new oak post

#### **10.1 Precept for 2015/16 :**

Cllr Ellis was not present at the meeting but had provided a written note to members in advance, which included the following information :  
Boughton Monchelsea Parish Council's precept is somewhere in the middle of the precepts set by all the Maidstone parishes. In the last three years the Parish Council has increased its precept above inflation to take into account the lost grant

money from MBC. The precept for 2015/16 should be increased in line with inflation and the appropriate inflation index which should be used is that calculated by the National Association of Local Authorities, shown as 2.2% when ignoring salary costs.

The precept for 2015/16 should therefore be set at £51,600 (note that the £600 increase over the 2% increase is the result of the increase in the rate poundage for the parish, i.e. more houses this year than last). For a band D property this precept level represents £41.55 per year, an increase of 81 pence from last year's level of £40.74. This equates to a rise of 1.5 pence per week.

Cllr Smith proposed that the precept level for 2015/16 be set at £51,600. Seconded by Cllr Herrin and agreed by all members.

The Borough Council's precept form was signed by both Cllr Munford and the clerk.

11.1 MBC – draft parish charter : The clerk noted that a draft parish charter had been received from MBC on 11<sup>th</sup> November 2014 and had been copied to all members. No response back to MBC was required at this stage.

11.3 LGBC – Electoral review of Kent County Council : The clerk explained that the Local Government Boundary Commission for England had formally commenced an electoral review of Kent County Council. It was agreed that the Parish Council should respond as follows :

The boundary of the parish of Boughton Monchelsea should be amended to include the following :

- All properties on the east side of Hubbards Lane (25 no) between Haste Hill Road and Heath Road
- All properties on the north side of Heath Road up to the Hubbards Lane / Heath Road junction (4 properties to add)

12.1 Cllr Munford noted that MBC would continue sending out hard copies of all planning application documents and drawings at present. He added that MBC were currently trialling the provision of electronic only copies with three Maidstone parishes.

12.2 Cllr Smith advised that a draft Neighbourhood Plan document would be provided to the Parish Council by Clare Wright by the end of January.

**13. Representatives' Reports:**

13.1 KALC: Cllr Ellis was not present at the meeting.

13.2 Allotments : Cllr Bracking had nothing to report.

Cllr Munford thanked Cllr Bracking for continuing on in his role as a Parish Councillor and allotment representative following his recent move to Loose.

Cllr Williams stated that Cornwallis school were looking for a garden / allotment area and suggested that there may be space for them to have a plot at the Parish Council's allotment site. Cllr Bracking to investigate. **CLLR BRACKING**

- 13.3 Village Hall & Recreation Ground : Cllr Whybrow stated that a rugby club would soon be using the recreation ground and that a contract was about to be signed. She stated that she would forward a copy of the draft agreement to the clerk.

Cllr Whybrow noted that there had been problems with the village hall bar service.

Cllr Whybrow noted that the Christmas fair that had taken place in the village hall had unfortunately not been very successful.

- 13.4 Neighbourhood Watch : It was noted that a new co-ordinator was still required. Clerk to find out date of next meeting. **CLERK**

- 13.5 PACT : Cllr Date was not present at the meeting.

- 13.6 Bus group : Cllr Whybrow noted that Sutton Valence had set up a volunteer transport service. Cllr Munford noted that grants were probably available for setting up and running this type of service.

- 13.7 Loose Valley Conservation Area : It was noted that as far as the Parish Council were aware, this group was no longer in existence.

#### 14. **Items for Discussion:**

- 14.1 Parkwood Farm reservoir, including sluice operation team for next two month period : Cllrs Munford and Herrin gave an update to members and noted that KCC had agreed to carry out a review of the previous studies and investigations undertaken on Shaw Stream and the Parkwood Farm reservoir. KCC had further advised that the report would help them understand the role of the reservoir and the benefit it provides.

- 14.2 North ward update : Nothing further to report

- 14.3 Works required to parish hut and trees on the green : It was noted that the following works were required to the parish hut :

- Re-fixing of slate tiles to roof
- Repair and renovation of timber doors, rather than simply the repainting work that had been previously thought adequate. The possibility of installing new doors to the hut was discussed but it was felt important to renovate and preserve the original doors
- Electrical check and repair / renewal of lights on gable end
- Removal of ivy

It was agreed that the clerk should be given delegated powers to authorise the above works to a total value of up to £800

**CLERK**

It was suggested that pollarding / size reduction work be carried out to the horse chestnut trees on the green. This was not thought necessary but the clerk was instructed to obtain advice from the Parish Council's landscape maintenance contractor.

Post meeting note : Advice obtained that any size reduction work is not necessary at this stage and would spoil the overall look and balance of the trees.

- 14.4 Cliff Hill – HGV signs : It was noted that a request had been made to KCC member, Cllr Eric Hotson, for funding for HGV signage at Cliff Hill.

- 14.5 Use of Facebook and twitter : Cllrs Gershon and Date were not present at the meeting so a full discussion on this subject did not take place. Cllr Williams advised that KCC use both social media platforms to convey information to the public and suggested that the Parish Council may be able to link in with this. Cllrs Gershon and Date to research this.

- 16.2 Cllr Whybrow noted that the village hall committee were updating their website and would like to add photos of events that have taken place in the hall.

- 16.3 Cllr Williams noted that a local church had been using the social club as their meeting place but had not had their lease renewed.
