#### Minutes of the Parish Council Meeting held on 6<sup>th</sup> July 2010 In Boughton Monchelsea Village Hall pursuant to notice, commencing at 7.30pm

### 1. Apologies:

Cllr Powell, Cllr Oliver, Cllr Williams, Cllr Clarke, Cllr Mike Fitzgerald.

- 2. Notification of late items for inclusion on the agenda It was agreed that items 14.16 and 14.17 should be included as late agenda items.
- 3. Standing Order 61: To decide whether the public and press should be excluded from the meeting for any item. It was agreed that items 14.4 and 14.16 should be considered as exempt items.
- 4. **Reports from Maidstone Police / PCSO and KCC Rural Community Warden** Apologies were received from PC Steve Older and PCSO Richard Chainey.

Crime figures were e-mailed to the clerk by PC Steve Older prior to the meeting and these are summarised as follows : two incidents of theft (catalytic convertor, catering equipment), one incident of vehicle interference (damage to car locks), one incident of criminal damage (hole in hedge) and one incident of assault (farm worker shot with air pellet).

KCC Warden, Liz Lovatt reported as follows :

- The Kent Community Warden Football Tournament will be taking place on 28<sup>th</sup> August and young adults with disabilities will be taking part. The Parish Council agreed to contribute £30 towards this event (for the purchase of trophies).
- A recent initiative has been undertaken to target rogue home improvement traders
- Residents should not buy or sell from cold callers
- A resident has been undertaking welding repairs at the roadside. This is a public safety issue and he has been advised to find a more suitable location

- An attempt was made to gain entry to a property in Haste Hill Close recently. Advice on home security or details of the 'Handyvan' service can be provided by Liz
- Any information regarding a smashed rear window at the village hall or vandalism to a section of hedge in Church Street should be reported to Kent Police or to Liz

### 5. Open Quarter:

A resident spoke with concern at the recent erection of goal posts on the open space at Boughton Court. The resident felt that one of the goal posts was sited too close to the road. She stated that balls were frequently hitting parked cars and that she was concerned at children running out into the road to retrieve balls. It was agreed that the goal post closest to the road should be removed. **CLERK** 

Cllr David Burton introduced himself as new Borough Councillor for Park Wood ward. He explained to Councillors that he is also Chairman of Langley Parish Council. Cllr Burton stated that the concurrent functions grants to Parish Councils are likely to be under threat in the future. Cllr Ellis asked by how much the grant is likely to be cut by and expressed concern as the grant gives a sizeable income to the Parish Council each year. Cllr Burton explained that early indications show an overall Borough Council budget deficit of 30% but could not advise on how and when any cutbacks would fall. Cllr Burton stated however that he would be campaigning for minimum cuts in the concurrent functions grant to Parish Councils.

### 6. **Declarations of Interests:**

Cllr Witherington declared an interest in item 14.2 Community Plan.

#### 7. Minutes of the last meeting:

The minutes of the meetings held on 4 May and 24 May 2010 were agreed as correct. Proposed by Cllr Bray, seconded by Cllr Ellis. Agreed by all Councillors.

#### 8. Clerk's Report:

The contents of the Clerk's Report were noted.

Item 4 of the clerk's report was discussed (possible retention of parking spaces at the 'Woodlands' housing development off Brishing Lane). It was agreed that a decision would need to be made by the Boughton Monchelsea Amenity Trust as the land is owned by them. Clerk to ask Wards if they can hold off removing the parking spaces until a decision has been made on whether a planning application should be made asking for them to be retained. Advice should also be sought from the Borough Council.

Cllr Munford spoke regarding the recent meeting at the Albion pub. KCC Warden, Liz Lovatt stated that she had only received three complaints from residents regarding alleged problems relating to noise and anti-social behaviour.

### 9. Matters arising from minutes not included in agenda

Cllr Bray stated that he had been very impressed with the quality of the catering by 'Fusion Healthy Living Centre' at the Annual Parish Meeting in May. Cllr Witherington and the clerk advised that they had passed on these sentiments to Fusion on behalf of the Parish Council.

- 12.1 Cllr Munford confirmed that he had spoken to Rob Jarman from the Borough Council recently regarding the land plots at Church Hill. Cllr Munford stated that Mr Jarman has agreed to meet with the Parish Council but is not prepared to 'go over old ground'. To be discussed further at planning committee meeting after the Parish Council meeting.
- 12.2 Cllr Munford confirmed that he had attended the recent Borough Council planning committee meeting with Cllr Williams and both had spoken against planning application MA/09/2004 (Cherry Tree caravan site, Church Hill). Cllr Munford thanked Cllr Williams for the excellent presentation she had given at the meeting. Cllr Munford stated that the Borough Council had been about to approve the application but had been informed about a new regulation whereby caravans / mobile homes have to be a minimum distance of 15m away from any surrounding woodland. Cllr Munford stated that as a result of this, the planning application must now be amended by the applicant and a decision on the application was deferred. Cllr Munford confirmed that he had asked the Borough Council to reconsider the 6 week unoccupied period recommended by the case officer. He stated that it is normal for caravan sites like this to be closed for 6 months from 1<sup>st</sup> October to 31<sup>st</sup> March and that a similar condition should be applied if the Borough Council are mindful to approve the application. The clerk advised that the Parish Council will have the chance to comment accordingly once the amended application has been submitted to the Borough Council.
- 12.3 Cllr Ellis noted that the Borough Council had approved planning application MA/10/0430 (Boughton Service Station, Heath Road). He stated that although the application has been approved, the fencing has not been erected in accordance with the application and requested that the clerk write to the Borough Council informing them accordingly. Proposed by Cllr Ellis, seconded by Cllr Witherington, agreed by all Councillors.

### 13. Representatives' Reports:

- 13.1 KALC : Cllr Ellis had nothing to report.
- 13.2 Allotments : Covered in item 14.15 below.
- 13.3 Village Hall & Recreation Ground: Cllr Bray stated that the village hall upgrade works are almost complete with just a few minor items to finish. He stated that the five a side goal posts for the basketball court are yet to be purchased. **CLLR BRAY**
- 13.4 Neighbourhood Watch : Cllr Witherington stated that the next Neighbourhood Watch meeting would be taking place on 13<sup>th</sup> July.

- 13.5 S&W Maidstone Traffic Management Partnership (TRAMP): Nothing to report
- 13.6 Neighbourhood Forum : Cllr Herrin reported that Boughton Monchelsea are no longer represented on this forum since the recent voting in of representatives.
- 13.7 PACT: Cllr Witherington had nothing to report.
- 13.8 Bus group : Nothing to report

### 14. Items for Discussion:

- 14.1 Website discussion of quotes and selection of website provider to proceed with : Cllr Witherington stated that he had assessed the quotes received from website providers and recommended that the Parish Council proceed with the quote from 'Esferico Ltd'. Proposed by Cllr Bray, seconded by Cllr Smith, agreed by all Councillors.
- 14.2 Community plan : Cllr Thompson stated that the launch date for the Community Plan will be delayed slightly due to the length of time taken to analyse all the data. She stated that the Plan will hopefully be published by the end of 2010.
- 14.3 Flooding, The Quarries : Cllr Herrin reported at length to Councillors on the proposed flood alleviation works. Cllr Herrin explained that the Parish Council have been awarded a grant of £69,000 to carry out this work and that the money must be spent by the end of March 2011. Cllr Smith queried whether it would be feasible to meet this deadline. Cllr Herrin stated that it would be. Cllr Ellis proposed that delegated powers be given to Cllr Herrin to instruct Evans & Langford to proceed with design work for the scheme. Seconded by Cllr Smith, agreed by all Councillors. It was noted that legal agreement will be required from the landowner to allow access on to the land as and when required during construction work and thereafter. **CLLR HERRIN**
- 14.4 Local needs affordable housing : Exempt item
- 14.5 Broadband upgrade : Cllr Witherington stated that he would be assessing supplier's proposals in the next few weeks. He explained that he had received 55 responses to the broadband survey that had been issued with the last newsletter and that there were 92 comments regarding broadband provision on the returned community plan questionnaires. Cllr Witherington stated that broadband proposers were expecting a 30% take up which equates to around 373 properties in the parish.

### **CLLR WITHERINGTON**

14.6 Beresfords Hill footpath : Cllr Evans stated that she would be contacting Kent County Council regarding the likely timescale if a compulsory purchase order was sought. Cllr Munford proposed that Cllr Evans should now pursue the compulsory purchase order for the land required to construct this footpath. Seconded by Cllr Ellis, agreed by all Councillors. Cllr Thompson suggested that due to some residents perhaps not realising the path exists, signage should be provided next to phase 1 of the Beresfords Hill footpath stating 'Please use footpath for your own safety'. Agreed by all Councillors. Clerk to progress.

It was noted that the footpath (ref KM334) was very overgrown and needed to be cut back urgently. Clerk to pursue with KCC.

- 14.7 Brishing Lane footpath : It was noted that part of the land required for this potential footpath is owned by the Boughton Monchelsea Amenity Trust.
- 14.8 Repairs to footpath adjacent to woodyard : Cllr Munford explained that the minor repairs carried out by the Parish Council had not been completed to the KCC specification and had been washed away during flooding earlier in the year. Cllr Munford stated that KCC have requested a £1500 contribution from the Parish Council to repair the footpath to a satisfactory standard. It was agreed that Cllr Munford should meet with the KCC footpaths officer and agree to KCC doing the work with a maximum contribution of £1500 from the Parish Council.

### **CLLR MUNFORD**

- 14.9 Strip of land to rear of Harling Close fencing and removal of trees by resident : It was agreed that a letter should be sent to relevant residents stating that the land is currently owned by the developer but will shortly be transferring to the Borough Council before being transferred to the Boughton Monchelsea Amenity Trust. The letter should state that the strip of land is designed as a buffer between the housing development and the open land beyond and that trees should not be cut or fencing moved under any circumstances. It was noted that affected properties back on to Pested Bars Road
- 14.10 Speedwatch : Cllr Herrin advised that the Police had co-ordinated an event where all parishes were out at the same time on 6<sup>th</sup> July doing speed watch checks. Cllr Date agreed to take over from Cllr Herrin as Speedwatch co-ordinator.

### CLLR HERRIN / CLLR DATE

14.11 Well on the Green : Cllrs Munford and Bray to progress. Cllr Bracking spoke regarding the poor state of repair of the 'Boughton Monchelsea' sign on the Green. Cllr Munford to liaise with Cllr Clarke regarding repairs.

### CLLR MUNFORD

- 14.12 Road junction improvement works Green Lane / Brishing Lane / Heath Road junction : Clerk to progress with Kent Highways.
- 14.13 Potholes in Green Lane : It was noted that pothole repairs were still outstanding. Clerk to pursue with Kent Highways **CLERK**
- 14.14 Goalposts at Boughton Court : Covered in item 5. above.
- 14.15 Allotment Association : Cllr Bracking advised that the 'Allotment Society' had had a number of meetings to date and that there were four people in the working party. Cllr Bracking explained that the society will be open to parishioners as well as allotment

holders (provided they wish to subscribe as members). Cllr Bracking asked that the next meeting be attended by some Councillors such that the constitution of the society can be formally agreed. Cllrs Bray and Thompson agreed to attend. Cllr Bracking to arrange meeting for late July.

#### 14.16 Exempt item

14.17 Donation to young adults special needs football tournament : It was noted that the Kent Community Warden Football Tournament will be taking place on 28<sup>th</sup> August and young adults with disabilities will be taking part. It was agreed that the Parish Council would contribute £30 towards this event (for the purchase of trophies). Proposed by Cllr Smith, seconded by Cllr Herrin. Agreed by all Councillors.

### 15. Deferred Items Schedule:

Furfield Quarry : Cllr Ellis confirmed that he had had a meeting regarding the methane monitoring to Furfield Quarry. He explained that the Trust Fund stands at approximately £1.3 million and that about £70,000 is being spent each year on methane extraction and that monitoring would need to continue for some time. He stated that the Skinner Trust want to erect a six foot high fence around the site to protect the extraction equipment. Cllr Ellis explained that the Skinner Trust have the right as landowner to erect the fence and that the overriding concern should be that the methane extraction plant remains in working order at all times. He stated that fencing would restrict access for residents walking over the land but that it would also prevent motorbike access. It was agreed that Cllr Ellis should contact the landowner to advise that the Parish Council will not oppose the erection of such fencing.

CLLR ELLIS

Land at Boughton Court : It was agreed that a letter should be written to the Borough Council chasing transfer of the land adjacent to Pested Bars Road from the Borough Council to the Boughton Monchelsea Amenity Trust.

Quarry Wood footpath : Cllr Munford advised that he had been in touch with the Scouts asking them to come up with a date for further work to the footpath.

### 16. Any other Business:

- 16.1 Cllr Thompson reminded Councillors that the next newsletter will be coming out in early September and that copy should be forwarded to her by the first week in August **ALL COUNCILLORS**

# **MINUTE 15** (Parish Council meeting 6 July 2010)
